3. **Minutes:** Previously circulated, taken as read and approved. (Please note that the minutes approved are of the previous meeting) The purpose of the meeting was to make arrangements for the Bonus Coaching day and wind down the season.

We know that children and parents will be disappointed that some members may not have been moved up a grade but it is hoped that the explanation that the standard of the boys is much more proficient and the gap between groups is widening and we do not wish to disadvantage any child by misplacing them in a group they will struggle with. It was anticipated from the interest shown in this years coaching programmes that several junior members would lose out in places next year and a bottle neck would occur in the mid section would result in no promotion progress being made for a year anyway. Spaces will be allocated on a first come first served basis. All levels apart from Beginners will be covered on the day.

A packed lunch will be provided, a scaled down version of Finals Day was agreed, vegetarians were noted.
